CAR PARKING: Please note there is NO CAR PARKING at Belsonic 2021 - please use the following website to find information on car parks www.belfastcity.gov.uk/carparking

BUS PARKING: There is permission for buses and coaches to park along Ormeau Embankment in Zoned areas. There is ONLY designated parking for buses. This parking facility is the most convenient location for ease of access and for passengers to get off and on safely under management of Belsonic. This facility will be sign posted and you will be required to walk in single file upon arrival. When departing, you will be required to continue along Ormeau Embankment and following the stewarding directions. All buses must approach site from embankments at Ormeau side, coaches will then drop you off and be parked in a designated zone. Upon arrival you will be told the Zone your bus will be parked in for you to return at the end of the concert.

TAXI DROP OFF: There is permission to allow taxis to drop off and pick up from both the Annadale Embankment at Dunnes Stores. Please note that these are the ONLY designated area for taxis.

For those with Limited mobility, there will be a disabled car park for Blue Badge holders. It is located on Ormeau Embankment across the road from the festival entrance. For safety reasons receptacles containing liquids will not be normally be permitted onsite. However, if you have a medical condition which requires you to bring liquid onsite you will be required to bring proof of your illness or condition and to advise security personnel at the entrance accordingly. Patrons should be aware that there is a full Medical Provision onsite as well as fresh drinking water. Necessary medicine, treatments and equipment that require special housing e.g. refrigeration can be held with our

- Photo ID is required for sale of alcohol at event. You are not permitted to bring alcohol onto the concert site and there will be searches in place. Please note it is concert goer's responsibility to prove their age when requested. YOU MUST have ID to prove your age especially if you are deemed to not meet age policies for the event.
- Note that official merchandise will be available within the concert only
- Arrange for after show pick-ups in the city centre due to traffic restrictions in place around the site.
- There are no re-admissions to the concert unless by prior arrangement through Belsonic. All Belsonic events are for those over 16 years of age.
- Plan your journey and please be aware that late-comers after the main act has taken to the stage may be refused admission.
- Contact a member of staff at the event if you have any queries or require any assistance during the event.

- Official valid Passport Government approved Proof of age card PASS or www.validateuk.co.uk

Student cards / Out of date documents / Photocopies or photos of ID's are not accepted.

IMPORTANT SECURITY INFORMATION

If you are attending Belsonic please be advised of additional security measures for all events. The safety of guests is of paramount importance to us, and an increased search regime will be in place. We would like to advise all guests to arrive at the venue in good time, as there will be enhanced personal searches on entry. Gates open at 5pm. In order to allow easy access, and cause minimal delays, we would like to discourage all guests from bringing bags to the event, and no luggage or large electronic devices (for example laptop computers) will be permitted. Small personal cameras will be permitted, though guests will not be able to bring professional photography equipment into the venue. Please note that you may also be asked to remove coats or jackets in the search queue. BELSONIC BELFAST – 2021 COVID-19 ENTRY REQUIREMENTS

YOU MUST have a valid Belsonic ticket to gain entry to the event you are attending, along with your proof of COVID Status.

In order to gain access to Belsonic events at Ormeau Park in September of 2021, ALL ticket holders will need to demonstrate their COVID-19 Status on entry by providing ONE of the following, listed below:

Proof of full vaccination - both doses received (with the second at least 14 days prior to the event you are attending)

OR

• Proof of a negative NHS Lateral Flow Test taken no more than 48 hours prior to your arrival at the event you are attending

OR

 Proof of natural COVID antibodies based upon a positive NHS PCR test within 180 days of the event you are attending (including 10 days self-isolation following the result).

TICKET HOLDERS FROM NORTHERN IRELAND

If you are resident in Northern Ireland, you can demonstrate your COVID-19 status by doing any ONE of the following:

1. Demonstrate proof of full vaccination by showing your COVID-19 Vaccination Card, that was issued to you when you received your vaccinations, at the entry gate. You must also show valid government issued Photo ID matching the name on your vaccination card.

In the event you had cause to use the COVIDCert NI Passport App to obtain proof of full vaccination for travel purposes, this proof is also acceptable to use for entry.

Other government issued proofs of full vaccination are also acceptable, provided you also produce valid government issued Photo ID.

- N.B. your proof of vaccination must reflect that you have had both doses of an NHS COVID-19 vaccine, and that your second dose was administered at least 14 days prior to the event you are attending.
- 2. If you cannot demonstrate that you have received both doses of an NHS COVID-19 vaccination, you will need to take a NHS Lateral Flow test no more than 48 hours prior to your arrival at the event you are attending. Assuming the result is negative, you must then report the result online at www.gov.uk/report-covid19-result and present your NHS email or text notification of your result at the entry gates.
- 3. Alternatively, you can also gain entry by demonstrating Proof of natural COVID antibodies based upon a positive NHS PCR test within 180 days of the event you are attending (including 10 days self-isolation following the result). You must present this proof at the entry gates to gain admittance.

TICKET HOLDERS FROM REPUBLIC OF IRELAND

If you live in Republic Of Ireland, you can demonstrate your COVID-19 status using the EU Digital COVID Certificate (DCC): www.gov.ie/en/publication/3a698-eu-digital-covid-certificate/

TICKET HOLDERS FROM ENGLAND

If you are resident in England, you can show your status easily via the NHS COVID Pass on the NHS App. For more information on how to do this, please see www.gov.uk/guidance/nhs-covid-pass

We recommend that you screenshot or download a copy of your NHS COVID Pass to your smartphone prior to arrival so that you have it ready to show at the entry gates. Alternatively, you can print a copy and bring this with you.

If you don't have access to a smartphone or computer, then you can call 119 to request a letter to demonstrate your vaccination status. Please note that the letter can take up to 5 working days to reach you. This letter will be sent to the address registered with your GP.

If you cannot access your NHS COVID Pass or if you do not receive a vaccination status letter in time you will need to provide evidence of a negative NHS Lateral Flow Test, by reporting the result at www.gov.uk/report-covid19-result and presenting your NHS email or text notification at the entry gates. The test must be taken no more than 48 hours before your arrival at the event you are attending.

Alternatively you can also gain entry by demonstrating Proof of natural COVID antibodies based upon a positive NHS PCR test within 180 days of the event you are attending (including 10 days self-isolation following the result).

TICKET HOLDERS FROM SCOTLAND

If you live in Scotland, you can obtain your full vaccination status at www.nhsinform.scot/covid-19-vaccine/after-your-vaccine/get-a-record-of-your-coronavirus-covid-19-vaccination-status

If you do not receive the letter in time, you will need to provide evidence of a negative NHS Lateral Flow Test, by reporting the result at www.gov.uk/report-covid19-result and presenting your NHS email or text notification at the entry gates. The test must be taken no more than 48 hours before your arrival at the event you are attending.

Alternatively you can also gain entry by demonstrating Proof of natural COVID antibodies based upon a positive NHS PCR test within 180 days of the event you are attending (including 10 days self-isolation following the result).

TICKET HOLDERS FROM WALES

If you live in Wales, you can obtain your full vaccination status by following the instructions at gov.wales/nhs-covid-pass-prove-your-vaccination-status

If you cannot access your NHS COVID Pass you will need to provide evidence of a negative NHS Lateral Flow Test, by reporting the result at www.gov.uk/report-covid19-result and presenting your NHS email or text notification at the entry gates. The test must be taken no more than 48 hours before your arrival at the event you are attending.

Alternatively, you can also gain entry by demonstrating Proof of natural COVID antibodies based upon a positive NHS PCR test within 180 days of the event you are attending (including 10 days self-isolation following the result).

OTHER TICKET HOLDERS (INTERNATIONAL)

All other ticket holders, not attending from any of the countries listed above, will be required to provide evidence of a negative NHS Lateral Flow Test, by presenting your NHS email or text notification at the entry gates. The test must be taken no more than 48 hours before your arrival at the event you are attending.

HOW TO UPLOAD YOUR NHS LATERAL FLOW TEST

If you are demonstrating your COVID-19 Status using an NHS Lateral Flow Test this should be taken the day prior to your arrival at the event you are attending. You can order NHS Lateral Flow Tests at ... www.gov.uk/order-coronavirus-rapid-lateral-flow-tests

Once you have taken your test, you will need to report your result on the NHS website at www.gov.uk/report-covid19-result You will receive a text or email notification confirming your negative test result, to present on entry.

A positive result from an NHS Lateral Flow Test means it's likely you had coronavirus when the test was done. You and anyone you live with must not attend the festival and self-isolate immediately. You are then advised to get a PCR test to confirm your result as soon as possible.

As per advice from Public Health Agency - patrons are advised to take a LFT 24 hours prior to the event and to take a LTF 2 days and 8 days after the event, only attend if you receive a negative result. www.nidirect.gov.uk/articles/coronavirus-covid-19-testing#toc-4
